Handling Procedures

1. Open vial according to enclosed instructions.

2. Using a single tube of #18 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.

3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.

5. Incubate all tubes and plate at 30°C for 24 to 48 hours.

Notes

Three colonial morphologies may be seen on #18 agar: a) 90% circular, entire, convex, opaque, and rough; b) 5% the same but with an erose margin; c) same as a but translucent.
