Handling Procedures

- 1. Thaw the frozen vial at room temperature.
- 2. Transfer the entire contents of the thawed vial into a single tube of #2039 broth (5 to 6 mL). Mix well.
- 3. Several drops of this suspension may be used to inoculate additional #2039 broth tubes.
- 4. Incubate the tubes at 26°C for 5-7 days. It may be helpful to incubate test tubes in a slanted position to increase gas exchange in the broth.

Notes

The cells are motile and rod-shaped.
