- 1. Open vial according to enclosed instructions.
- 2. Aseptically transfer an aliquot into a tube of the recommended broth.
- 3. Several drops of the suspension can also be used to inoculate a #18 agar slant and/or plate.
- 4. Incubate the tubes and plate at 30°C for 24 hours.

Notes

Two colony types observed on #18 agar are: a) entire, glistening, circular, smooth, low convex, opaque; and b) entire, circular, smooth, translucent, and raised.
