Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

Frozen ampoules packed in dry ice should either be thawed immediately or stored in liquid nitrogen. If liquid nitrogen storage facilities are not available, frozen ampoules may be stored at or below -70°C for approximately one week. **Do not under any circumstance store frozen ampoules at refrigerator freezer temperatures**

(generally -20°C). Storage of frozen material at this temperature will result in the death of the culture.

1. To thaw a frozen ampoule, place in a 37°C water bath, for 2 minutes then place ampoule on bench top until just thawed. Immerse the ampoule just sufficient to cover the frozen material. Do not agitate the ampoule.
2. Immediately after thawing, wipe down ampoule with 70% ethanol and aseptically transfer at least 50 µL (or 2-3 agar cubes) of the contents onto a plate or broth of medium recommended.
3. Incubate the inoculum/strain at the temperature and conditions recommended.
4. Inspect for growth of the inoculum/strain regularly. The sign of viability is noticeable typically after 5-7 days of incubation. However, the time necessary for significant growth will vary from strain to strain.

Morphology: After 5 days on V8 rye medium at 20°C colonies appressed with radiating strands and sparse aerial mycelia. Sporangia are abundant.

Plant pathogen; mating type A2; deposited as *Phytophthora capsici* Leonian.
