Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submerged in liquid nitrogen.

ATCC Medium 44: Brain Heart Infusion Agar/Broth

ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

**Temperature:** 37°C

**Atmosphere:** 95% Air, 5% CO<sub>2</sub>

## Handling Procedures

1. Open vial.
2. From a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.
3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
4. Use several drops of this suspension to inoculate a #260 agar slant and/or

plate.

5. Incubate the tubes and plate at 37°C for 24-48 hours in an atmosphere of 5% CO<sub>2</sub>. Screw caps should be loose.

**Notes**

On #260 plates, colonies are entire, smooth, and exhibit alpha hemolysis.
