## Growth Conditions

### Medium:

ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

ATCC Medium 44: Brain Heart Infusion Agar/Broth

**Temperature:** 37°C

**Atmosphere:** Aerobic

## Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #44 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.

5. Incubate the tubes and plate at 37°C for 24 to 48 hours.

## Notes

Colonies on #260 agar are white, translucent, circular, entire, low, convex, and smooth. This strain exhibits a faint beta hemolysis that is best seen after a colony is removed from the agar surface.
