Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. From a single tube of #2 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette and use to rehydrate the pellet.
- 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
- 4. Use several drops of this suspension to inoculate an additional broth tube, a #2 agar slant and/or a plate.

5. Incubate the tubes and plate at 18°C-22°C for 48 hours.

Notes

This strain will not grow at 30°C, the optimal temperature being 20 +/- 2°C. It will grow at 26°C, but seems to be biochemically unreactive. Characterization must be done at the lower temperature.

Colonies are circular, regular in shape, translucent, and unpigmented. Cells are Gram negative coccobacilli and motile.

Organism will not grow in the absence of NaCl.
