Handling Procedures

Centrifuge tube prior to opening to prevent loss of pelleted material

- 1. Rehydrate contents of vial with molecular grade H₂O.
- 2. Place vial at 37°C for 1 hour or at 2°C to 8°C overnight.
- 3. For more complete rehydration and to fully recover DNA, incubate the sample overnight at 4°C while rocking; then incubate for 1 hour at 65°C. Resuspending the dried DNA in \geq 250 µL may give better results.

Quality Control Specifications

Total amount: Total DNA by PicoGreen[®] measurement was found to be approximately 5 μg.
Purity (A260/A280): 1.6 to 2.0
Integrity: Integrity of DNA was determined by electrophoresis on a 1% agarose gel stained with SYBR Safe[™], and was found to be of high molecular weight.
