# Handling Procedures

1. Open vial according to enclosed instructions.

2. Using a single tube of #18 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.

3. To obtain a biphasic culture, add 0.4 ml of the suspension to a #260 slant. Add remaining 0.1 ml of the suspension to a #260 plate and streak for isolation.

#### Notes

The use of FRESH media is of primary importance.

Colonies on #260 agar are white, entire, glistening, circular, and smooth. Good growth will be present at the broth-agar interface. Under phase microscopy the organisms appear as small rods, singly or in clumps, and non-motile.
