# Handling Procedures

- 1. Open the freeze-dried vial according to enclosed instructions.
- 2. Using a single tube of #18 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml



with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.

- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #18 slant, and/or plate
- 5. Incubate all tubes and plates at 37°C for 24 hours.

#### Notes

Colonies on #18 agar are entire, glistening, smooth, translucent, and gray. Colonies wrinkle with age.
