# **Handling Procedures**

1. Open vial according to enclosed instructions.



- 2. Using a single tube of #18 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate an additional broth tube, a #18 agar slant and/or a plate.
- 5. Incubate all tubes and plate at 37°C for 24 hours.

#### Notes

Colonies on #18 plates are entire, smooth, glistening, slightly opaque, and gray. Colonies develop a wrinkled appearance with age.
