## Handling Procedures

1. Open vial according to enclosed instructions and allow to thaw completely.
2. Aseptically transfer the entire contents of the vial into a #2131 broth tube. A slant and a pre-reduced blood plate may be inoculated with 0.1 ml each of the cell suspension. An aerobic blood plate may also be streaked to check for purity.
3. Incubate tubes and plate under anaerobic conditions at 37°C. Incubate blood

plate aerobically at 37°C.

4. After 4 to 7 days, growth should be evident by light turbidity and a color change in the broth from a pink to a light yellow. Growth may also be checked under a microscope using phase contrast. Cells are spiral-shaped and may exhibit motility. Growth does not readily occur on blood plates. No growth should occur on the blood agar plate incubated aerobically.

#### ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber, or
- Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber,
- Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.
