Handling Procedures

1. Open vial according to enclosed instructions.
 2. From a single tube of #1511 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette and use to rehydrate the entire pellet.
 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
 4. Use several drops of this suspension to inoculate an additional broth tube, a #1511 agar slant and/or a plate.
 5. Incubate tubes and plate under 5% CO₂ at 37°C for 24 hours.
