Handling Procedures

- 1. Open vial according to enclosed instructions.
- From a single tube of #1511 broth (5 to 6 mL), withdraw approximately 0.5 to
 mL with a Pasteur or 1.0 mL pipette and use to rehydrate the entire pellet.
- 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.

- 4. Use several drops of this suspension to inoculate an additional broth tube, a#1511 agar slant and/or a plate.
- 5. Incubate tubes and plate under 5% CO₂ at 37°C for 24 hours.
