## Handling Procedures

1. Open vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
2. Under anaerobic conditions, aseptically rehydrate the entire pellet using approximately 0.5 mL of #2106 broth. Aseptically transfer the entire contents to a test tube of 5-6 mL of #2106 broth. Additional test tubes can be inoculated by transferring 0.5 mL from the primary broth tube to secondary

broth tubes. Best practice dictates the use of pre-reduced media.

3. Use several drops of the primary broth to inoculate a #2106 agar slant and/or plate.
4. Incubate in an anaerobic atmosphere at 30°C for 48-72 hours. Incubate one plate aerobically at 37°C to check for contamination.

#### ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber.
- Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber.
- Loose screw caps on test tubes in an activated anaerobic gas pack jar.
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.
