## Handling Procedures

1. Open vial according to enclosed instructions.

2. Under anaerobic conditions, withdraw 0.5 ml of #1053 from a single test tube (5 to 6 ml) and rehydrate the vial contents.

3. Aseptically transfer this aliquot back into the broth tube. Additional tubes may be inoculated with 0.5 ml each from the suspension. A slant of #1053 may also be inoculated with 0.2 ml. Streak several blood plates to check for colonial morphology and purity.

4. Incubate tubes under an anaerobic atmosphere at 37°C. Incubate one agar plate

anaerobically for colony formation, and one aerobically for aerobic contamination check.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

 $\cdot$  Use of an anaerobic gas chamber, or

· Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

· Loose screw caps on test tubes in anaerobic chamber,

 $\cdot$  Loose screw caps on test tubes in an activated anaerobic gas pack jar, or

 $\cdot$  Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

#### Notes

Within 3 to 4 days, growth should be evident by turbidity in the broth and colonies on the agar surfaces. Colonies on the anaerobic blood plate are small and entire with a smooth surface. No growth should occur on the blood agar plate incubated aerobically.
