For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

### **Growth Conditions**

#### **Medium:**

ATCC Medium 2236: GM medium with 4-Chlorophenol

**Temperature:** 26°C

**Atmosphere:** Aerobic

### **Handling Procedures**

1. Open vial according to enclosed instructions.
2. From a single tube of #2236 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the pellet.
3. Use 0.1 ml of this suspension to inoculate #2236 slants and 0.1ml to inoculate #2236 plates.

4. Incubate tubes and plates at 26°C, under aerobic conditions, for 2-3 days.

5. After 2-3 days of incubation, wash cells from the slant and transfer this broth to a new slant and plate. Incubate another 2-3 days under aerobic conditions. This second transfer and incubation is necessary for complete removal of the cryoprotectant, which can inhibit growth.

### **Notes**

At 3 days, growth on agar yields convex colonies, 1-2 mm in diameter, with entire margins and an opaque to pearl-white hue.

Cells display a rod-coccus life cycle. Some motility is observed in broth at 2-4 days. Density is high in 3 days.
