Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #814 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use 0.2 mL of the suspension to inoculate a #814 slant, and/or 0.1 mL for a

plate.

5. Incubate all tubes and plate at 37°C with 5% CO₂ for 24 to 48 hours. Assure that screw caps are loose during incubation period.

Notes

Brain Heart Infusion (Difco 0037) can be used to rehydrate vial contents if #814 broth is not available, but it will not support growth as well as the GC broth.
