Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #18 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.

5. Incubate the tubes and plate at 37°C for 48 hours.

Notes

On #18 agar colonies are circular, entire, and opaque. This organism will also grow in 5% CO₂, but grows more lush under microaerophilic conditions.
