# **Handling Procedures**

- 1. Open vial according to enclosed instructions.
- 2. From a single tube of the recommended broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or
  - 1.0 ml pipette and use to rehydrate the pellet.



- 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
- 5. After growth has been achieved, additional transfers may be made.

#### Notes

Growth on solid medium will take one to two weeks. Colonies on #173 plates are entire, heaped, clear, and smooth. After 3 weeks incubation a second colony type appears. It is buff to yellow and raised.
