### Handling Procedures

Centrifuge tube prior to opening to prevent loss of pelleted material

1. Rehydrate contents of vial with molecular grade H<sub>2</sub>O.
2. Place vial at 37°C for 1 hour or at 2°C to 8°C overnight.
3. For more complete rehydration and to fully recover DNA, incubate the sample overnight at 4°C while rocking; then incubate for 1 hour at 65°C. Resuspending the dried DNA in  $\geq$  250  $\mu$ L may give better results.

### Quality Control Specifications

**Electrophoresis - RNA content:** No RNA was detected by electrophoresis

**Total amount:** Total DNA by PicoGreen® measurement was found to be approximately 5  $\mu$ g.

**Purity (A260/A280):** 1.6 to 2.0

**Integrity:** Integrity of DNA was determined by electrophoresis on a 1% agarose gel stained with SYBR Safe™, and was found to be of high molecular weight.

**Functional tests:** Functional activity was confirmed by PCR amplification 16S ribosomal RNA gene.

**Identity:** Identity confirmed by sequencing of 16S ribosomal RNA gene (first  $\sim$  500 base pairs).
