Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Handling Procedures

1. Open vial according to enclosed instructions or visit [www.atcc.org](http://www.atcc.org) for instructions.
2. Prior to inoculation, add 1 M Sodium Acetate solution (final concentration 5 mM) and 1 M FeSO<sub>4</sub> solution (final concentration 10 mM).
3. Under anaerobic conditions aseptically rehydrate the entire pellet with approximately 0.5 mL of #2865 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #2865 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes.

Best practice dictates the use of pre-reduced media.

4. Use several drops of the primary broth tube to inoculate a #2865 plate and/or #2865 agar slant.
5. Incubate in an anaerobic atmosphere at 20°C to 26°C for 5 to 28 days. Incubate in a slanted position under a tungsten lamp at a distance of 30 cm. Incubate one agar plate aerobically at 37°C to check for contamination.

#### ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by the use of an anaerobic gas chamber or placement of test tubes under a gassing cannula system connected to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in an anaerobic chamber
- Loose screw caps on test tubes in an activated anaerobic gas pack jar
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained

## Notes

Grows best in broth or a stab. Growth on agar may take up to 5 weeks and needs to be observed under magnification. Colonies are minute, circular, entire, translucent, and a faint orange color.

Always use freshly prepared pre-reduced media or pre-reduced media that has been previously prepared but stored under anaerobic conditions.
