Handling Procedures

- Centrifuge tube prior to opening to prevent loss of pelleted material
 - 1. Rehydrate contents of vial with molecular grade H₂O.
 - 2. Place vial at 37°C for 1 hour or at 2°C to 8°C overnight.
 - 3. For more complete rehydration and to fully recover DNA, incubate the sample overnight at 4°C while rocking; then incubate for 1 hour at 65°C. Resuspending the dried DNA in ≥ 250 µ may give better results.

Quality Control Specifications

- Electrophoresis RNA content No RNA was detected by electrophoresis
- Total amount Total DNA by PicoGreen® measurement was found to be approximately 5 g.
- **Purity (A260/A280)** 1.6 to 2.0
- **Integrity** Integrity of DNA was determined by electrophoresis on a 1% agarose gel stained with SYBR SafeTM, and was found to be of high molecular weight.
- **Functional tests** Functional activity was confirmed by PCR amplification of the 16S ribosomal RNA gene.
- **Identity** Identity confirmed by sequencing of 16S ribosomal RNA gene (first ~500 base pairs).
