Handling Procedures

1. Open vial according to enclosed instructions.
2. Using 0.5 ml of #18 broth, rehydrate the entire vial contents.
3. Aseptically transfer 0.2 ml of this suspension to #2192 slant(s), and/or 0.1 ml to plates.
4. Incubate tubes and plates at 37°C in an atmosphere of 5% CO₂

Notes

Within 48 hours incubation, growth on #2192 agar appears as small, circular, convex, pale yellow colonies. This organism does not grow in broth culture.
