**Medium:** 

ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

Temperature: 37°C

Atmosphere: 95% Air, 5% CO<sub>2</sub>

## **Handling Procedures**

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.

- 4. Use several drops of the suspension to inoculate a #260 agar slant and/or plate.
- 5. Incubate the tubes and plate at  $37^{\circ}$ C for 24 hours. To enhance growth, place tubes and plates in an atmosphere of 5% CO<sub>2</sub>.

#### Notes

On #260 plates, colonies are entire, glistening, circular, smooth, opaque, raised, and exhibit beta hemolysis. This strain also grows on #44 plates.
