## Handling Procedures

1. Open vial according to enclosed instructions.
2. From a single tube of #461 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the pellet.
3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
4. Use several drops of this suspension to inoculate an additional broth tube, a #461

agar slant and/or a plate.

5. Incubate the tubes and plate at 70°C for 24 and 48 hours.

## Notes

*Thermus antranikianii* is Gram negative aerobic rod-shaped cell. On solid media, the colonies are circular and yellow.
