Handling Procedures

1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.
2. Rehydrate the entire pellet with approximately 0.5 mL of #1099 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #1099 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
3. Use several drops of the primary broth tube to inoculate a #1099 plate and/or #1099 agar slant.

4. Incubate at 28°C for 7-10 days.

Notes

Colonies on #1099 agar appear small, circular, entire, glistening, smooth and low convex. Cells occur as non-motile rods in singles and pairs.
