Handling Procedures

1. Open vial according to enclosed instructions.
2. From a single tube of #1395 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and rehydrate the entire pellet.
3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
4. Heavily inoculate a slant of #90 and/or a plate of #173 agar.

5. Incubate all tubes and plate at 26°C for 3-4 weeks. After growth has been achieved, additional transfers may be made.

Notes

Colonies on #173 agar are irregular, wrinkled, dry, and off-white.
