Growth Conditions

Medium: ATCC Medium 416: Lactobacilli MRS Agar/Broth Temperature: 26°C or 37°C Atmosphere: Aerobic; 95% Air, 5% CO₂

Handling Procedures

- 1. Open vial.
- Rehydrate the entire pellet with approximately 0.5 mL of #416 broth.
 Aseptically transfer the entire contents to a 5-6 mL tube of #416 broth.
 Additional test tubes can be inoculated by transferring 0.5 mL of the primary

broth tube to these secondary broth tubes.

- 3. Use several drops of the primary broth tube to inoculate a #416 plate and/or #416 agar slant.
- 4. Incubate at 26°C or 37°C for 48 to 72 hours aerobically or in an atmosphere of 5% CO_2 .

Notes

After 48 to 72 hours, growth is evident by turbidity in the broth and the formation of colonies on the slant and/or plate.
