For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

#### **Medium:**

ATCC Medium 416: Lactobacilli MRS Agar/Broth

**Temperature:** 26°C

**Atmosphere:** Aerobic

### **Handling Procedures**

1. Open vial.
2. Rehydrate the entire pellet with approximately 0.5 mL of #416 broth.  
Aseptically transfer the entire contents to a 5-6 mL tube of #416 broth.  
Additional test tubes can be inoculated by transferring 0.5 mL of the primary

broth tube to these secondary tubes.

3. Use several drops of the primary broth tube to inoculate a #416 plate and/or #416 agar slant.
4. Incubate at 26°C for 48 to 72 hours.

---

### **Notes**

Colonies on #416 agar at 48 hours are pinpoint and white. At 72 hours, colonies are more distinct, circular, entire, and white.

Cells are non-motile, short to medium-length rods arranged in singles and a few short chains. Rods may be straight or curled.
