Handling Procedures

1. Open vial according to enclosed instructions.
3. Using a single tube of #3 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.

4. Aseptically transfer this aliquot back into the broth tube. Mix well.
 5. Use several drops of the suspension to inoculate a second tube of broth, a slant, and/or plate.
 6. Incubate all tubes and plate at 37°C for 24 hours.

Notes

Colonies on #3 agar are glistening, translucent, and smooth with an irregular margin. If growth is sparse on initial agar slant or plate, reinoculate from incubated broth.
