Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Medium:

ATCC Medium 2107: Modified Reinforced Clostridial

ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

Temperature: 37°C

Atmosphere: Anaerobic

Handling Procedures

1. Open vial according to enclosed instructions.
2. Under anaerobic conditions, withdraw 0.5 mL of #2107 from a single test tube (5 to 6 mL) and rehydrate the entire vial contents.
3. Aseptically transfer this aliquot back into the broth tube. Additional tubes may be inoculated with 0.5 mL each from the suspension. Streak several blood

plates to check for colony morphology and purity.

4. Incubate tubes under an anaerobic atmosphere at 37°C. Incubate one agar plate anaerobically for colony formation, and one aerobically for aerobic contamination check.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber, or
- Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber,
- Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

Notes

In 24 to 48 hours, growth is evident by good turbidity in the broth and by colonies on the anaerobic agar surfaces. After 48 hours, the colonies are raised, undulate edge, white, and glistening. No growth should occur on the aerobic plate.

Brucella agar can be used to analyze colony morphology and purity.
