One of 9 shuttle vectors (ATCC 87585 ? 87593) allowing lacZ detection of cloned inserts and containing the pUC19 MCS with all 10 cloning sites unique. Vectors differ in mode of replication (YE, YC or YI-type) and yeast marker (LEU2, URA3 or TRP1). This is a YE-type (yeast episomal) vector with the TRP1 marker. The HindIII, PstI and XbaI restriction sites from the TRP1 gene of *S. cerevisiae* were removed by using oligodirected mutatgenesis.
