Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

#### Handling Procedures

 Remove the desired number of cryopreserved reference culture vials (gray crimp) and rehydration buffer vials (green crimp) from 2-8°C storage and place into a biosafety cabinet. One vial of rehydration buffer should be used for each vial of reference culture.

- 2. Uncap each vial. Add 1.0 mL of rehydration buffer to the reference culture vial. Recap the vial and allow the pellet to dissolve for 30 seconds.
- 3. Vortex on high for 30 seconds to ensure the suspension is well mixed. The suspension is now useable and contains 100-1000 CFU per 1.0 mL. The suspension can be used immediately or stored at 2-8°C for up to 8 hours.
- Uncap the vial and pipette 100 μL of the resuspended reference culture directly on a non-selective media agar plate. If following a specific pharmacopeial chapter, use the appropriate media specified. Note: ATCC quantitation results were obtained using 100 mm Tryptic Soy Agar plates with 1.5% Tryptone, 0.5% Soytone, 0.5% Sodium Chloide, and 1.5% Agar (plates were procured from Teknova<sup>®</sup>).
- 5. Use a sterile plate spreader (not provided) to spread the sample evenly over the surface of the media plate. Do not use glass beads. Incubate the plates in an incubator at the appropriate temperature (see the product page or product sheet). If following a specific pharmacopeial chapter, use the incubation conditions specified.
- 6. Following incubation, count the number of visible colonies on the plate.
