Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. From a single tube of #416 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.
- 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well
- 4. Use several drops of this suspension to inoculate a second tube of broth, a slant



and/or a plate.

5. Incubate tubes and plate at 37°C for 24 to 48 hours.

Notes

Microscopic examination shows the cells to be small rods, in singles, pairs and chains.

On #416 agar colonies are white, smooth, glistening, high convex, and entire. CO 2 is not required but may enhance growth.
