Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## **Handling Procedures**

- 1. Open vial according to enclosed instructions.
- 2. From a single tube of #44 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.
- 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
- 4. Use several drops of this suspension to inoculate an additional broth tube, a #260 agar slant and/or a plate.
- 5. Incubate the tubes and plate at 37°C for 24 hours.

#### Notes

Colonies on #260 plates are entire, glistening, circular, smooth, and exhibit betahemolysis. This strain is a member of Lancefield's Group C.

Sequencing of the 16S rRNA gene identifies this item as *Streptococcus dysgalactiae* subsp. *equisimilis*.
