Handling Procedures

For freeze-dry (lyophilized) ampoules:

- 1. Open an ampoule according to enclosed instructions.
- 2. From a single test tube of sterile distilled water (5 to 6 mL), withdraw

approximately 0.5 to 1.0 mL with a sterile pipette and apply directly to the pellet. Stir to form a suspension.

- 3. Aseptically transfer the suspension back into the test tube of sterile distilled water.
- Let the test tube sit at room temperature (25°C) undisturbed for at least 2 hours; longer (e.g., overnight) rehydration might increase viability of some fungi.
- 5. Mix the suspension well. Use several drops (or make dilutions if desired) to inoculate recommended solid or liquid medium. Include a control that receives no inoculum.
- 6. Incubate the inoculum at the propagation conditions recommended.
- 7. Inspect for growth of the inoculum/strain regularly. The sign of viability is noticeable typically after 2-4 days of incubation. However, the time necessary for significant growth will vary from strain to strain.

Morphology: After 3 days at 25°C on malt extract agar, the cells are ovoidal to globose, (2.3-5.0) x (4.0-10.0) μ m, or more elongate; colonies are coral-red to salmon or orange, and smooth.
