Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## **Handling Procedures**

1. Open vial according to enclosed instructions.
2. From a single tube of #3 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.
3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.

4. Incubate at 26°C for 72 hours.
  5. After growth has been achieved, use several drops of the suspension to inoculate a second tube of broth, a slant, and/or plate.

## **Notes**

This organism prefers growth in broth. Cells appear as curved rods and helical cells with some long filaments.

Colonies on Nutrient Agar are entire, glistening, smooth, drop-like, pinpoint, and translucent.
