Handling Procedures

Centrifuge tube prior to opening to prevent loss of pelleted material

1. Rehydrate contents of vial with molecular grade H₂O.
2. Place vial at 37°C for 1 hour or at 2°C to 8°C overnight.

For more complete rehydration and to fully recover DNA, incubate the sample overnight at 4°C while rocking; then incubate for 1 hour at 65°C. Resuspending the dried DNA in ≥ 250 µL may give better results.

Quality Control Specifications

Electrophoresis - RNA content: No RNA was detected by electrophoresis

Total amount: Total DNA by PicoGreen measurement was found to be approximately 5 µg.

Integrity: Integrity of DNA was determined by electrophoresis on a 1% agarose gel stained with SYBR Safe™, and was found to be intact and of high molecular weight.

Functional tests: Functional activity was confirmed by PCR amplification 16S ribosomal RNA gene.

Identity: Identity confirmed by sequencing of 16S ribosomal RNA gene (first ~ 500 base pairs).

Notes

Bacterial genomic DNA is provided in a dried form. Store at 2°C to 8°C upon receipt. Store at -20°C if stored for more than 6 months. Note: Do not store in freezers with a defrost cycle. This will expose the product to increased temperatures.
