Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or glass pipette. Rehydrate the entire pellet.
3. Transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate a second tube of broth, a slant, and/or plate.
  5. Incubate all tubes and plate at 37°C for 24 hours.

On #3 agar, two colony types are observed: a) entire, glistening, circular, smooth, small, translucent; and b) entire glistening circular, smooth, large, opaque
