### Description

Screening fee is applied to specific ATCC cell lines designated for "Screening Use". "Screening Use" is defined as use of the applicable cell line in small molecule and biologic drug discovery, including initial target identification and validation, assay development, high throughput screening, hit identification, lead optimization, and selection of candidates for clinical development.

**As of March FY2026, ATCC has transitioned the screening fee to a one-time fee payable for each product intended for screening use.**

**If you have added the screening fee to our products in the past – no further action is needed. We do not require any renewal fees going forward. For new screening uses we no longer require the Material Transfer Agreement Addendum for Screening Applications.**
