Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. From a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette and use to rehydrate the entire pellet.
- 3. Use 0.1 mL of this suspension to inoculate #3 slants and 0.1mL to inoculate #3 plates.
- 4. Incubate tubes and plates at 26°C, under aerobic conditions, for 2 days.

5. After 2 days of incubation, wash cells from the slant and transfer this broth to a new slant and plate. Incubate another 2 days under aerobic conditions. This second transfer and incubation is necessary for complete removal of the cryoprotectant, which can inhibit growth.
