Handling Procedures

1. Open vial according to enclosed instructions.

2. Using a single tube of #2508 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.

- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Incubate the broth tube for 24 to 48 hours at 37°C.
- 5. Transfers can now be made to other tubes of broth, slants, and/or plates.

Colonies are circular, glistening, smooth, raised, and translucent. Cells are motile rods found singly or in chains. Strain will also grow on ATCC Medium #2, Marine Medium 2216 (BD 212185. Additional information on this culture is available on the ATCC[®] web site at <u>www.atcc.org</u>.
