Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

### Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. From a single tube of the recommended broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.
- 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
- 4. Use several drops of this suspension to inoculate an additional broth tube, an agar slant and/or a plate.

5. Incubate the tubes and plate at 10°C for 4 days.

#### Notes

Cells are motile pleomorphic rods. Colonies on #2 agar are entire, circular, translucent, creamy and low convex.
