Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

# Handling Procedures

1. Open vial according to enclosed instructions.

2. From a single tube of #396 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.

3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.

4. Use several drops of this suspension to inoculate an additional broth tube, a #396 agar slant and/or a plate.

5. Incubate the tubes and plate at 30°C for 24 to 48 hours.

#### Notes

On #396 agar colonies are entire, circular, off-white, and raised. Cells are beanshaped and prosthecated, with budding at the ends of the prosthecae. Cells also form clumps and rosettes in broth.
