Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. From a single tube of #18 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.
- 3. Use 0.1 ml of this suspension to inoculate #18 slants and 0.1ml to inoculate #18 plates.
- 4. Incubate tubes and plates at 30°C, under aerobic conditions, for 24 hours.
- 5. After 24 hours of incubation, wash cells from the slant and transfer this broth to a

new slant and plate. Incubate another 24 hours under aerobic conditions. This second transfer and incubation is necessary for complete removal of the cryoprotectant, which can inhibit growth.

#### Notes

Growth on agar at 24 hours yields mucoid colonies

3-6 mm in diameter.

Cells are Gram positive, motile rods occurring in chains.
