Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Under anaerobic conditions, withdraw 0.5 ml of the recommended broth from a single test tube (5 to 6 ml) and rehydrate the vial contents.
- 4. Incubate tubes under an anaerobic atmosphere at 30°C. Incubate one agar plate aerobic contamination check.
- 5. Growth will take 7 days with a doubling time of 21 hours. The growth can be increase on a shaker incubator at 150-180 rpm. The cells are cocci and will form aggregates.

ANAFROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- ·Use of an anaerobic gas chamber, or
- ·Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- ·Loose screw caps on test tubes in anaerobic chamber,
- ·Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- ·Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.
