Handling Procedures

- 1. Let the vial thaw at room temperature.
- 2. Transfer the entire contents of the vial to a single tube of #2 broth. Mix well.
- 3. Use several drops of the suspension to inoculate a #2 agar slant and plate(s).
- 4. Incubate the tubes and plate at 10°C for 10 to 14 days.

Notes

Colonies vary in size. On Marine agar colonies are yellow, brown, rounded, smooth, glistening, and entire. To ensure growth all culture work should be done on ice.
