Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Under anaerobic conditions, withdraw 0.5 ml of the appropriate medium from a single test tube (5 to 6 ml) and rehydrate the entire vial contents.
- 3. Aseptically transfer this aliquot back into the broth tube. Additional tubes and an anaerobic #260 agar plate may be inoculated with 0.5 ml each from the suspension. Streak onto an additional blood plate and incubate aerobically to check for purity.
- 4. Incubate tubes and one #260 plate under an anaerobic atmosphere at 37°C.

#### ANAEROBIC CONDITIONS:

- $\cdot$  Tubes of media are placed under a gassing cannula system hooked to a source of oxygen-free gas.
- · All transfers are performed while the test tubes are on the cannula system with a gentle stream of oxygen free gas flowing through the system.
- $\cdot$  As the test tubes are removed from the cannula system each is sealed with butyl rubber stopper thus maintaining the anaerobic headspace. A 100% nitrogen or 80% nitrogen-20% carbon dioxide gas mixture is typically employed as the oxygen-free gas source.

#### Notes

In 48-72 hours, growth is evident in broth by slight turbidity. Good growth on plates is obtained after 72hrs of incubation. Colonies on #260 agar are small, entire, circular, and convex. No growth should be observed on aerobic plate.
