Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

- 1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.
- 2. Rehydrate the entire pellet with approximately 0.5 mL of #814 broth.

 Aseptically transfer the entire contents to a 5-6 mL tube of #814 broth.

 Additional test tubes can be inoculated by transferring 0.5 mL of the primary

broth tube to these secondary broth tubes.

- 3. Use several drops of the primary broth tube to inoculate a #814 plate and/or #814 agar slant.
- 4. Incubate at 37°C for 24-48 hours in an atmosphere of 5% CO₂.

Notes

ATCC Medium #44: BHI or ATCC Medium 2167: Haemophilus Test Medium, can be used for rehydration purposes, but not growth.
